Payton Gendron's Manifesto Mentions 'Great Replacement Theory' & Brenton Tarrant As Buffalo Mass Shooting Inspiration

Payton Gendron's manifesto reveals his twisted reasons for carrying out the massacre on Saturday, May 14, 2022. At least 10 were killed, and 3 were injured. 11 out of those 13 were African Americans, 1 was the supermarket's security guard – a recently retired police officer, and others were the employees.

The **Buffalo** mass shooting shooter **Payton Gendron** had posted a 180-page **manifesto** on

Google Drive. The Tops Friendly supermarket murderer was driven to kill by the 'great

replacement theory.' It states that native inhabitants are being urged to extinction by

The manifesto of Payton Gendron focuses on the great replacement theory. The theory claims that Democrats favor migrants from the other countries for votes while deliberately outnumbering whites in the US.

When The Reporter Times asked Payton why he chose the upstate New York store for his

mission, he replied that it had the same zip code, 14208, and it had the highest black

Payton's manifesto shows that he had planned and outlined everything prior to hitting the store. It included a sketch map of the store, which he didn't let anyone know before the

shooting. It's because it would have fallen in the hands of law enforcement, as well, as he

Per the manifesto, the internet radicalized Gendron rather than anyone he met in real life. It

also stated that he got inspiration from Brenton Tarrant, who is a white supremacist. In

2019, Tarrant had live-streamed himself when he murdered 51 Muslims at a mosque in Christchurch, New Zealand.

Gendron said that Tarrant radicalized him the most when asked who or what had spurred him to mass murder blacks. He killed 10 people while 3 were injured. In the manifesto, Payton mentions another white supremacist and mass murderer, Dylann Roof. In 2015, Roof

mass murdered 9 blacks at a South Carolina church in 2015. Another inspiration was

Norwegian killer Anders Breivik who had killed 77 people back in 2011.

believed to be authentic, Gendron used a fake photograph of himself. The photo he used to

The names of the victims have been released. The first one is 86 years old Grandmother

Ruth Whitfield. She was shopping for eggs in the supermarket. The second one is security

guard Aaron Salter. He was the father of three children. Salter fired at Gendron after seeing

-At home I will pick up all my genr and put it in an industrial trash bag, then I will put this bag in a laundry backet and place it on the floor in front of the passenger seat. I will put the three gam.

-I will follow my planned course of action and make sure I know exactly where to go between

-At 3:30 I will park in the designated gear up spot off of Sherman St and fully gear up. I will take my 3 guns out of their carriers and put them in the passenger seat of my car. I chamber the


(two of them have carriers) behind my seat with a blanket over them to cover it from outsiders. I will also have discord at my house running a live recording of my twitch account.

The plan of action:



-I shoot all downed blacks twice in the head, making my way to the register and aisles again, and back to the deli and back to the entrance. -It should be leaving at about 4:04. -Then I will go into my car and make it south on Jefferson Ave. Where I will take my Mossberg 500 and Savage Axis out from the seat and shoot at blacks on the streets. Yeah.docx-1.pdf Sign In -If all is expected I should pass some responding patrol officers at this time on Jefferson. -I pass the House of China and start making my way across the Emilie neighborhoods, using all weapons I have available to me to shoot at nearby blacks. -I should be stopped by police officers eventually in Emslie and then surrender to them. Or if I find another decent location the day of the attack (example being Walmart) I'll bead there. Most importantly, the attacker must go through with the attack in their mind, it is very difficult for a normal person even with all the information to earry out an attack that will kill another human being, or the fact that you may die that day. I don't think there really is a way to train for this, but confidence in your goals and equipment may ease them. I think that live streaming this attack gives me some motivation in the way that I know that some people will be cheering for me. I am also decently protected by my armor so that gives me some confidence as well. Training with my guns also gives me confidence knowing exactly what I can expect by The Weapon Of course how is one expected to kill another without a weapon? I will be using finearms as my primary weapon for this attack. Why? Because they work. There are very few weapons

that are easier to use, accessible, and effective at killing than firearms. The weapons I will be using for this attack are a Bushmaster XM-15, Mossberg 500, and a Savage Axis XP.

This is my Bushmaster XM-15. That's right, I used the dreaded military grade assault rifle-15 as my main firearm for this attack. This gain was most likely made between 1994 and 2004, when the Federal Assault Weapons Han was still in action. I bought it from a place in Endicott called Vintage Firearms. Since I live in New York, I had to buy a cucked version of this before illegally modifying it. The person who had this before me initalled a Mean Arms magazine lock, which fixed a 10 mund magazine (higher capacity magazines are also illegal) to

Bushmaster XM-15 E2S Target

-1 first shoot the security guard and kill him by shooting through the front doors of the glass. His most common areas are located in orange. -1 make it on the other side of the airles and continue firing on all blacks, I go into the customers only area to check for numers and hiders, and make it to the deli and then back to the entrance.

As mentioned in his manifesto, Payton Gendron hates blacks, Jews, left-wing people, and transgender. He has written about his monotonous life in Conklin, New York, in the document. Payton lives around 200 miles or 3.5 hours away from Buffalo.

Per Gendron, he was never diagnosed with a mental disorder. Police arrested the killer / suspect when he walked out of the supermarket. They took him before the court on Saturday night. Payton has been charged with one count of first-degree murder.

Gendron said that he understood what the charge was. But his lawyer said that he would

his manifesto, he was supposed to confess and plead guilty to his crimes.

deny it in court. As opposed to his manifesto, he rejected the charges for his crimes. But, in

It looks like Gendron would face federal hate crime and terrorism charges. All of it could see

him put to death.
